 - i. Career Discovery Day 4/21/23
 - ii. Summer Institute plans underway
 - iii. Forklift class in December
 - iv. Atlas program (transportation & logistics); truck driving program is extremely expensive
 - 1. developing more courses for supply chain management
 - b. Berkeley City College
 - i. Advisory committees: CIS, Video Automation, Business
 - ii. BACCC just approved for virtual production certificate: collaboration with 6 colleges; fully articulating classes
 - iii. When will degree audit system be implemented at Peralta? No recent update and no implementation yet
 - 1. Dr. Droker: still waiting on one college to complete work on transcripts
 - c. Laney College
 - i. LCTAC winners: Johnny Williams, Sidney Thomas, David Chavez
 - Passed resolution to censure Tim Thomas at LCTAC meeting and faculty senate over concerns at Laney (Fab Lab and student's stolen vehicles, no communication)
 - iii. Facilities issues adversely affecting CE faculty: no heat, boilers down
 - 1. \$1.3 million for football field approved
 - 2. Processes and procedures are not being followed
 - 3. Bond funds can be used
 - 4. Request: VC of Facilities attend the next meeting
 - d. Merritt College
 - i. Also facing facilities issues (hot water, heat)
 - ii. Jennifer Briffa Memorial
 - iii. Challenging to hear from others on what's happening with CE; campuses need to do better if people are to return
 - iv. Also tasked with recruiting program partners, but the systems are preventing quality relationships from developing (contracts, status updates, spending/PO) no smooth way to move through systems

 - a. What CE programs are good for going abroad?
 - b. What funding is available to support study abroad and students in CE fields?
 - i. BCC LAEP students can be paid for internships (non profit v profit-based companies)
 - 1. le: virtual production with Belfast University students would get minimum wage for a set number of hours to help offset costs of the trip (internships abroad)
 - 2. The teacher would be hiring students for the internship
 - c. Employer partners (Genentech, etc.)
 - d. CIRM Grant
 - e. International Students: "option practical training," "curricular practical training" (CO-Ped)
 - i. How to improve services
 - ii. Online programs (degree & certificate programs) huge influx in international students interested in enrolling online from their home country (80-100 students) – many ask, "what degree can I complete online?"
 - 1. CA Virtual Campus (CVC)
 - a. Developments are underway currently in Phase 1 and expected to be a teaching after June 2023
 - b. All Peralta courses are on CVC exchange, but CC Apply is required for students who want to enroll
 - 2. CE programs are a little difficult for online instruction because most require hands-on work
 - Peralta as a whole is applying to be a teaching college (any student can apply to college outside of Peralta; not via cc apply) – students statewide can sign up for classes/classes will be visible to everyone
 - 4. BCC Virtual Production working towards AA program and Bachelor's program, collectively supported by 6 colleges (will be fully online)
